- This arrangement shall not confer any preferential right on them to claim promotion on substantive basis which shall be made under rules by the DPC;
- The above said arrangement will be without prejudice to the superior claims of others and subject to the outcome of writ petitions, if any pending before any competent court of Law.
- This arrangement shall be liable for reversion if the vacancy is required for consideration to justify the superior claim of any other official without further notice at any time.
